New guidance issued for management representations

The APESB has issued APES GN 41 *Management Representations* to assist professional accountants who prepare, review and approve management representation statements.

The APESB Chair, the Honourable Nicola Roxon, said this guidance will help ensure that management representations are prepared or presented fairly and honestly in accordance with the APES 110 *Code of Ethics for Professional Accountants*, regardless of whether the representations are used internally by management or boards, or alternatively provided to an external party.

APES GN 41 is directed primarily at chief financial officers or those in senior finance roles, but also provides specific guidance for professional accountants at different levels of an organisation in respect of their responsibilities.

Progress on IESBA's Long Association project

At its recent September Board Meeting, the International Ethics Standards Board for Accountants (IESBA) approved for close-off its pronouncement *Long Association of Personnel with an Audit Client* (Long Association).

The provisions will state that for a key audit partner for a Public Interest Entity (PIE), the maximum time on period will be seven years followed by a five year cooling off period (subject to the application of jurisdictional safeguards). For engagement partners other than the key audit partner, the same maximum time on period will apply with a cooling off period of two years. IESBA has not yet announced the effective date for these provisions.

Stakeholder engagement

Over the last two months the APESB have continued to engage extensively with stakeholders across a number of forums.

In August, our Chair, the Honourable Nicola Roxon, was a panellist at the Chartered Accountants Australia and New Zealand (CA ANZ) Public Sector Symposium on Ethics in Banking and Financial Services. In conjunction with this symposium, CA ANZ released [A Question of Ethics -](#)

Navigating Ethical Failure in the Banking and Financial Services.

At CPA Australia's annual conference, CPA Congress, Ms Roxon presented on the topic *Towards exemplary professionalism and ethics amongst accountants*. This presentation considered how the APESB pronouncements help accountants act professionally and ethically.
